4.3 New Club Applications

4.3.1 Craft Beer Appreciation Society

CG declares a conflict of interest.

SP notes that a similar society was rejected in 2013 due to the similarity with Brewsical, however Brewsical are now currently unregistered (since April 1st 2017). There could then be an overlap if Brewsical decides to register again.

NM says that she and Craft Beer Appreciation Society have both attempted to contact Brewsical, but have not heard back. SP responds saying that this shows their disinterest in engaging with the C&S Program.

Alexander Blackwell enters the meeting at 3.22pm.

RM says that we need to be wary about alcohol-themed clubs, especially if alcohol is part of their main aims. I.e. Events need to be in licensed areas.

LA also adds that the club needs to be aware that the C&S program will not fund events such as pubcrawls or a brewery tour.

SP then concludes that based on the issues the committee has discussed, and the merits of their application the club should be accepted.
